Abstract-The study of the Historical Approach is very important to study in more depth. This is because these studies never stop being debated. The aim of this article is to understand 3 things: First, the paradigm of the historical approach in Islamic studies. Second, internal and external factors that influence the Historical Approach in Islamic Studies. Third, positive and negative implications. From a historical approach in the study of Islam towards community life. The method used by Lebelary Research is a qualitative approach based on Islamic historical theory. Meanwhile, data collection is done by collecting articles and books related to the theme of historical printing and analyzing them using qualitative data analysis techniques. The results found were 3 things: First, the paradigm... there are 3 forms of historical approaches in Islamic studies: (1) social (2) biographical (3) civilization. Second, internal influences... There are 3 factors in the historical approach: (1) research methodology (2) historical sources (3) intellectual tradition. Externally, there are 3 factors that influence the historical approach: (1) politics (2) technology (3) culture. Third, the positive implications of a historical approach to the lives of Muslim communities are 3 things: (1) deeper understanding (2) openness to change (3) relevance to modern challenges. Meanwhile, there are 3 negative implications of the historical approach to people's lives: (1) limitations in interpretation (2) limitations in sources (3) potential for contextual misunderstandings. The conclusion is that this paper shows the urgency both theoretically, methodologically and practically.

### Introduction

The study of historical approaches in Islamic studies is interesting to debate. This is because this theme contains elements of Controversial, Conflict, Trending, Viral and Emergency (CCTVE). There are 3 things that show the urgency of the title being discussed: First, conceptually the study of the historical approach in Islamic studies is how to understand the history of the Islamic religion from various points of view: time, place, important figures, and cultural context. It aims to explore the evolution of Islam from the past to the present using primary sources such as the Koran, Hadith, classical literature and historical records (Hopefully 2023). Second, functionally the historical approach study serves to provide an in-depth understanding of Islamic teachings from a historical perspective, reveal the evolution of Muslim religion and society, provide an important historical perspective in decision making, and strengthen awareness of identity and respect for the cultural heritage of Muslim society (Haryanto 2017); Third, the historical approach to Islamic studies provides theoretical contributions in the form of the evolution of religion, religious practices and the social structure of Muslim society (Haryanto 2017), and practical contributions in the form of policy guidance, contributing to religious and cultural education, as well as relevant religious interpretations in everyday life (Ilyas 2022). The three things mentioned above show how important it is for this theme to be studied in more depth.

Previous studies related to the theme of this article apparently have 3 tendencies: First, the article on the theme "The History of the Legal Prohibition of Khamr in Islam through a Historical Approach" tends to only be discussed from the perspective of the history of social and cultural change, discussing history as an approach in the study of Islam, especially in Islam. . This journal highlights the similarities in historical patterns and Islamic education in looking at various cases in scientific buildings (Chairunisa 2022). Second, writings on the theme "Historical and Pragmatic Approaches to Industry and Ikm in the City of Gresik" tend to only be discussed from the historical aspect of industrial activity, which provides insight into how history influences industrial processes (Reza Akbar Mauliza, Ingrid Debby Ekza Veronica, and Muhammad Yasin 2023). Third, writings on the theme "Islamic Studies in a Normative and Historical View" tend to only be discussed from a conceptual perspective, discussing the balance between normative and historical. This journal highlights the importance of a deep understanding of history ('Adzim and Vrikati 2020). Meanwhile, this article tends to discuss 3 things: form, paradigm, and historical approach factors that influence it and its implications for people's lives, so this article is clearly different from previous writings.

The aim of this paper is to understand 3 things: First, the paradigm of the Historical Approach in Islamic Studies. This is related to forms with the theme of the Historical Approach in Islamic Studies. Second, the factors that influence the Historical Approach in Islamic Studies. This is related to internal and external factors, that supports or hinders. Third, the implications of the Historical Approach in Islamic Studies on people's lives. This is related to the positive and negative impacts that arise.

There are 3 arguments that strengthen this article, namely as follows: First, historically the theme of the historical approach in Islamic studies has been an interesting research subject. This approach aims to integrate history and Islam, as well as understand the level of religion that a person understands, lives and practices in the Islamic context (Kartini et al., 2023; Effendi, 2021). Second, philosophically, the historical approach in Islamic studies can be considered as an attempt to understand Islamic teachings, practices and values through a historical lens 2019) Third, methodologically, the theme of the historical approach in the Islamic studies approach involves several important steps that help in understanding, analyzing and interpreting Islamic teachings in their historical context (Sulastri, 2022;(Rozali 2020)).

## Literature review Approach

The study of approaches has an understanding of etymology, terminology and certain characteristics. As for etymology, the study with the theme of approach is that the word approach comes from the derivation of the word near, meaning not far. After getting the prefix pe and the suffix an, the meaning becomes a process or way of approaching an object or problem (KBBI, 2021). Meanwhile, in terms of terminology, the study with an approach theme means that the term is a way or method used to study or solve a particular problem or object (Afroni, 2019;Rozali, 2020). Studies with an approach theme have the following characteristics: the existence of a philosophy or theoretical framework, objectives, methods and techniques, approach to data, understanding of phenomena, approach to conclusions, flexibility (Rozali 2020).

Study of the approach is divided into several types, types and certain patterns according to the categories used. The classification of approach themes is divided into 7 types, namely Qualitative Approach, Quantitative Approach, Mixed Methods Approach, Experimental Approach, Phenomenological Approach, Grounded Theory Approach, Historical Approach (Syadzili 2020). In terms of approach, there are 8 types, namely Systemic Approach, Theory Based Approach, Cognitive Approach, Behavioristic Approach, Humanistic Approach, Ecological Approach, Feminist Approach, Postmodernist Approach (Ismail, Umar, and Mubaraq 2023). Meanwhile, in terms of approach, there are 2 patterns, namely the statistical approach and the syntactic or structural approach (Rokhyanto, Salamah, and M 2021).

#### Historical

Historical studies have an understanding of etymology, terminology and certain characteristics. As for ethimology, the study with the Historical theme shows that the word Historical comes from the language date, sirah (Arabic) which means the provisions of the period (Nuralifia et al., 2023), history (English), and geschicte (German)(Adib 2022). In line with that, there is also the use of the word istoria in defining history, namely explaining phenomena, especially human affairs, in chronological order (Assingkily 2021). Meanwhile, in terms of terminology, studies with a historical theme mean that the term is knowledge or descriptions of events and happenings that actually happened in the past.(Assingkily, 2021;Islam et al., 2023). Studies with a Historical theme have the following characteristics: Historical sources, time engineering, interpretation and interpretation, subjective perspective, social and cultural context, change and continuity, influence and impact, research and methodology, interpretive nature, evolution of knowledge, cross-cultural understanding and emphasis on narrative (Septiani, 2019;Shofwan, 2020).

Study ofHistorical is divided into several types, types and certain patterns according to the categories used. Historical theme classification is divided into two types, namely Subjective Historical and Objective Historical (Taringan, Aprila, and Pratama 2019). As for the subjective aspect, there are five types, namely subjectivity, personal judgment, subjective sources, narrative flexibility, and cultural point of view (Martha et al. 2023). Meanwhile, from the objective side, there are four patterns, namely objectivity, minimal personal assessment, objective sources, strict narrative and scientific methodology (Azizah and Anwar 2023).

### **Islamic Studies**

The study of Islamic Studies has an etymology, terminology and certain characteristics. As for etymology, the study with the theme Islamic Studies means that the word Islamic Studies comes from English, namely Islamic Studies, and in Arabic it is dirasat al-Islamiyah. (Syafaq 2021). Meanwhile, in terms of terminology, the study with the theme Islamic Studies means that this term represents the teachings of Islam itself which are studied in various aspects and various schools of thought. What this means is, an effort to understand by analyzing things related to the religion of Islam, the main points of its teachings, its history, and its implementation in life through several methods and approaches that can conceptually provide a view of Islam (Amruddin et al. 2022). Studies with the theme Islamic Studies have the following characteristics: study matters related to the Islamic religion, have the aim of studying Islam in depth, consciously and systematically arranged (Daud Yahya et al. 2022).

The study of Islamic Studies is divided into several types, types and certain patterns according to the categories used. The classification of Islamic Studies themes is divided into 4 types, namely aspects of religion, history, theology and Muslim culture(Achrom 2019). As for

Islamic studies, there are 9 types, namely Al-Quran Studies, Hadith Studies, Jurisprudence Studies, Islamic History Studies, Islamic Theology Studies, Sufism Studies, Islamic Thought Studies, Gender and Islamic Studies, Contemporary Islamic Studies(Daud Yahya et al. 2022). Meanwhile, in terms of Islamic studies, there are 5 patterns, namely the pattern of Islamic studies including normative, historical, social, philosophical and psychological studies (H. Mubarok and Mansur 2023).

#### Research Methods

Unit of Analysis: The focus of the study is limited to only 3 things: First, related to forms of historical approaches. This in detail includes various forms that illustrate the themes above, forms of historical approaches are approaches that use a historical perspective in the study of events, phenomena or topics particular from a historical point of view. Second, the factors that influenced the emergence of this form. This in detail includes various factors, both internal and external, which illustrate the themes above, both supporting and hindering the emergence of these forms. Third, the various implications of the historicist approach to society. This in detail includes the various implications or impacts that arise directly or indirectly, both positive and negative, which illustrate the theme above. These three things are discussed in this article so that the study does not expand to other things.

Research Type: Research used with library research or literature studies with a qualitative approach based on general psychological theory to strengthen studies on this theme. Library Research is library research by examining sources in the form of books, manuscripts, notes, etc (Abduh et al. 2022). This research is useful for obtaining information on similar research, deepening theoretical studies, sharpening methodology and deepening data collection. The reasons for using this research are; because the research problem can only be answered through library research, library research is needed as a separate stage, namely a preliminary study to understand more deeply new phenomena that are developing in the field or in society and library data remains reliable for answering research questions (Melfianora 2019). The characteristics of literature studies are in the form of; first, research deals directly with text or numerical data and not with direct knowledge from the field or eye witnesses in the form of events, people or other objects; second, library data is ready to use; third, that library data is generally a secondary source; fourth, that the condition of library data is not limited by space and time(Mustafa and Suryadi 2022).

Data Analysis Technique: Data in the form of literature is analyzed using descriptive analysis techniques in accordance with Library Research procedures with the following stages: First, classification, where library data is collected and grouped based on certain criteria. This helps researchers to organize data so that it is easier to manage and analyze. Second, categorization, where data that has been grouped in the classification stage is further organized into more specific categories or certain topics. This helps in determining the focus of a deeper analysis. Third, codification, where each data or information in these categories is given a certain code or label.
